Chair's remarks – Stacy had a meeting with President Bowman reported the following:

- Gambling legislation is currently stalled due to the debate of slot machines at racetracks, thus all capital project money is stalled from approval and release

- The State of Illinois has a backlog of paying its bills of \$5b
- The State of Illinois is up to date for distributions for this FY, but still owes \$23.7M from last FY
- Retirement legislation will probably be debated in the Spring Veto session.
- Performance funding for Universities is going forward, discussions are still happening; will start with a small percentage, with more information in December regarding the metrics for grading
- Questions and concerns raised at the last meeting by Council members over the campuswide technology assessment were shared with President Bowman. His response was that there is no talk of people losing their job. This is an assessment to ensure efficiency across campus and it may result in some reorganization, but there is too much work to be done to even think about cutting staff.
