MINUTES

This is the beginning of the 20 year plan (to be reviewed along the way). Motion for AP Council endorsement by Debbie Lamb, second by Nikki Brauer. The plan will be presented to the BOT on February 18, 2011.

Approval of minutes –January 13, 2011 minutes were approved motion by Anjie Almeda, second by Julie Huber

Chair's remarks – Stacy reported that the search committee members for the VP for Student Affairs search committee were listed in the REPORT. Stacy talked with Steve Klay regarding the proposed constitution. Steve suggested that additional position descriptions be added. Stacy will reconvene the committee this spring. Stacy reported from her meeting with President Bowman that the University has received \$6.5M of \$73M State of IL appropriated dollars for this fiscal year, which did not yet include any monies for MAP. The University received remaining FY10 monies in December 2010. President Bowman still feels that the financial position of the university is good, and that staff cuts are unlikely due to the state tax increase and decrease of the payment cycle. He is not expecting any additional monies this year which would equate to no staff raises. President Bowman doesn't feel that a lot of businesses will be lured out of state, especially once they realize the bottom line. He feels that the bigger threat is loss of manufacturing jobs to other countries. He noted that out of state student recruitment is getting more difficult. He also commented that he anticipates the State of IL will ask universities/employees to pay more toward healthcare costs, and that we may see a potential tax on pensions. He noted that the state tax increase will be noticeable in staff paychecks. He also commented that the bond for Redbird Arena will be paid off this year. When asked about the Football Stadium improvements, he noted a student referendum and a substantial increase in private dollars would be needed to make this project a success.
