GUEST: Julie Jenson & Pam Beach re: iPeople Project; and Jim Carlson re: SURS – Pam and Julie gave an overview of the iPeople Project to Council members. May 2nd is Benefit Choice and July 1st HR/Payroll will be done via iPeople. iPeople is web based and will give better access to employment data (HR/Benefit components) via employee self service. All paper time cards will be done – as of July 1st all will be reported & approved electronically, three direct deposit options will be available as well as access to check advice and W-2. All employees will also report positive time worked as to bring ISU in compliance with the SOEEA Ethics Act. Benefit Choice begins May 2nd, and a ruling on the Health Alliance and Humana protest is expected on May 9th. As of July 1st, all paper enrollment is gone. MCAP, DCAP, sick bank and FMLA will be online through iPeople. Training sessions will be available online and around campus.

Jim Carlson reported as a member of the SURS advisory committee there will be upcoming changes to the annuity tables used to calculate retirement due to the 5 year experience study done by SURS. An effective date will be determined in June to be placed into effect sometime between Jan 2nd and July 2nd, 2012. This will affect those employees that are 55 year of age or 30 years of service credit who have chosen the portable and traditional plans. Jim recommended using the SURS website and if there are questions to please contact SURS.
