Graduate numbers for this fall have gone up by 25% for applications for admissions. They have about 2,500 graduate students that make up 11% of the overall student body. They are looking to grow numbers by 1,000 over the next ten years. They are looking to bring in more external funding. They have several graduate initiatives they are working on.
