Provost Everts spent time with Council members detailing her first impressions of ISU. She told the council that having been on campus for only two months, she finds ISU warm and welcoming to all faculty, staff, students and community members and feels that it would be great to be a student here. She came to ISU because of our national reputation but was quick to point out that she hasn't seen nor sensed an ego about the accomplishments of the university, continuing to say that faculty and staff have the attitude of 'that's our job'.
