4) Treasurer's Report - Heidi Verticchio

5) Human Resources Report - Melanie Fata

Fair Labor Standards Act—new minimum salary required for exempt employees is now \$35,568 per year. Employees at lower rates will need to be brought up to the minimum or they will be eligible for overtime. Several administrative searches are going on:

- Associate VP for facilities—search is well along in the process
- OEOA Director—Jeff Lange is currently serving as interim
- Provost's search-search firm being used for that; University has used the firm in the past
- Milner Dean search-will be posted soon, within the next week or two
- AVP of Research and Graduate Studies—search committee is meeting this week
- AVP for Academic Programs-will be posted soon •
- AVP for Student Affairs-will be launching late winter or early spring

Dual Career Program-trying to find job placement for a trailing spouse, either in the community or on campus.
